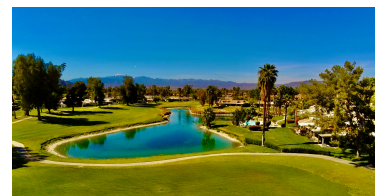

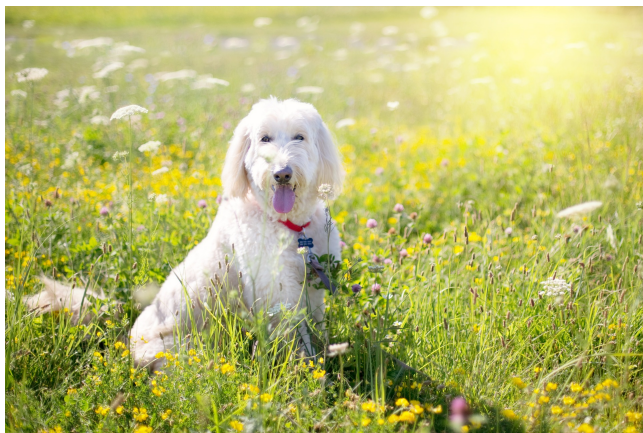

VMB Wellness Evaluation Committee Recruitment—Deadline Extended to June 30

The Veterinary Medical Board (VMB) is currently recruiting candidates to fill two vacancies on the VMB's Wellness Evaluation Committee (WEC), a five-member committee comprised of three licensed veterinarians and two public members. The purpose of the WEC is to rehabilitate veterinarians and registered veterinary technician with impairment due to abuse of dangerous drugs or alcohol affecting competency so that they can be treated and safely return to the practice of veterinary medicine.
