



Federal authorities issued warning letters to four companies that are accused of selling unapproved cannabidiol products as drugs for people and animals. Warning letters sent by the U.S. Food and Drug Administration state that the companies made unproven claims that administering their CBD-containing products would provide therapeutic benefits for a variety of animals, including food-producing animals. Company websites and social media posts advertised that the products could help animals such as dogs, cats, horses, cattle, and alpacas by reducing stress, relieving pain. controlling seizures, and reducing inflammation, according to the warning letters.
